Request for Quote: Geographic Information System (GIS) Services

Inuvialuit Regional Corporation (IRC) is seeking a contractor to review the alignment between Canada Lands Survey plans for Inuvialuit Private Lands and the metes and bounds in Annexes D-1, F-1, F-2, G-1, G-2, H-1, H-5, I-1, I-5, J-1, J-5, K-1, K-5 of the Inuvialuit Final Agreement (subject to corrections and notes about the text contained in Appendix 1 of this RFQ).

The successful proponent must provide:

- a report analyzing any differences between the survey plans and the IFA text
- a georeferenced image for each page of the IFA survey atlases
- a shapefile that reflects the current extent of Inuvialuit Private Lands (including subsurface rights), by adjusting the metes and boundaries according to Appendix 1 and 2 of this RFQ.
- a list of all reference documents used, such as NTS mapsheets and air photos

Background

With the signing of the 1984 Inuvialuit Final Agreement (IFA), Inuvialuit, as represented by IRC were granted fee simple title to over 90,000 square kilometres of lands in the Western Arctic region of the Northwest Territories ("Inuvialuit Lands"). The lands are divided into two categories: 7(1)(a) lands and 7(1)(b), with different subsurface ownership rights. These lands were surveyed by Canada Lands Company surveyors over the 80s and 90s and registered with the NWT Land Titles Office, but IRC has not verified the survey plans to ensure they conform with the metes and bounds. Additionally, there have been changes to the boundaries of Inuvialuit Private Lands for various reasons in the intervening years, including the addition of new subsurface rights and easements.



Proposal Format

Submission

- Must be submitted electronically to the contact below no later than the deadline on the cover of this RFQ or modified through an addendum.
- Include all required documentation, drawings, specifications and cost estimates as outlined in the RFQ.

Timeline

- Proposals must include a schedule highlighting key milestones.
- The project must be complete by March 14, 2025. The ability to commit to a tighter timeline will be considered an asset in evaluation.
- Use the submission form (Appendix 3)..

Experience

- Proposals must highlight the experience of the project team required to complete the project
- Project team must have demonstrated experience working on similar projects. Include details of relevant projects completed.

Cost breakdown

• Submit a cost proposal for the completion of the project, not including GST, using the submission form (Appendix 3).

Evaluation

- Proposals will be evaluated based on experience, cost, completion timeline and evidence of ability to complete the project.
- The selection committee reserves the right to reject any proposal and to negotiate terms with selected bidders.
 Preference will be given to Inuvialuit-owned businesses and/or proponents and proponents who can clearly demonstrate and agree that employment opportunities will be extended to beneficiaries of the Inuvialuit Final Agreement ("IFA").

Terms

- The successful bidder will be required to enter a formal contract with Inuvialuit Regional Corporation outlining the terms and conditions of the project
- Contract negotiations will commence following the selection of the preferred bidder.

Scope of Work

The successful proponent must provide:

- a report analyzing any differences between the survey plans and the IFA
- a georeferenced image for each page of the IFA survey atlases
- a shapefile that reflects the current extent of Inuvialuit Private Lands (including subsurface rights), by adjusting the metes and boundaries according to Appendix 1 and 2 of this RFQ. a list of all reference documents used, such as NTS mapsheets and air photos

Relevant documents

- Canada Lands survey plans 75719, 75720, 75721, available for free as an unreferenced multi-sheet PDFs from the Canada Lands Survey.
- The 2005 consolidation of the IFA, available at https://irc.inuvialuit.com/documents/the-inuvialuit-final-agreement/ Appendixes 1 and 2 of this RFQ.

The contractor shall use the NTS maps indicated in the IFA annexes as the references for the locations of natural boundaries such as rivers and coastlines. Where those are not applicable, natural references should be aligned with official sources from the time of survey, or as close as possible. An analysis of the changes in the location of natural boundaries is outside the scope of this project.



Appendix 1: Known errors in the IFA metes and bounds, and amendments not included in the 2005 Consolidation.

Annex F-1

Delete "thence westerly along latitude 68° 20 to its intersection with longitude 135° 15" and replace it with "thence westerly along latitude 68° 20 to its intersection with longitude 136° 15"

Annex F-2

Two amendments were made to this annex:

"following the words fifthly add "Commencing at the point on the southwesterly bank of Shallow Bay at latitude 68° 46' and approximate longitude 135° 41' 50"; thence westerly along latitude 68° 46' to a point on the easterly bank of an unnamed channel at approximate longitude 135° 43' 30"; thence northeasterly and southeasterly along the sinuosities of the banks of said unnamed channel and Shallow Bay to the point of commencement."

This appears to create an impossible polygon. Contractor should assume the surveyor's work reflects the intent of the IFA and include a disclaimer in the polygon data in the shapefile.

Annex G-2

delete 69° 02' 10; add "69° 01 "' delete 69° 01'; add "69° 02' 10"

Annex K-5

There is some conflict between the IFA survey and the later Nunavut boundary survey around the mouth of the Kugaluk River and Bell Island. The contractor will use the natural boundaries used in the NTS maps listed in the IFA. This requires additional discussions with NRCan.
