Background

Inuvialuit Regional Corporation (IRC) was established in 1984 to manage the settlement outlined in the Inuvialuit Final Agreement (IFA) and to represent the collective interests of the Inuvialuit. IRC's mandate is to continually improve the economic, social and cultural wellbeing of the Inuvialuit through the implementation of the IFA and by all other available means. Today, IRC is made up of 53 organizations with over 400 employees.

The IRC Home Repair Program aims to support a wide range of home improvement needs, including accessibility modifications, safety enhancements and general maintenance to promote community wellbeing and quality of life.

Objective

The purpose of this RFQ is to procure, load, transport and unload sixteen (16) high-cube (HC) containers, each with a capacity of one twenty-foot equivalent unit (1 TEU), to a specific location (TBD) in the Edmonton area. These containers will be used for storage and other operational needs.

Scope of Work

Supply 16 individual 1 TEC HC rear-door-only containers:

- Provide 16 new high-cube containers that have been used for only one trip (1-trip).
- Containers must have rear doors only and meet all relevant standards for durability, security and weather resistance.

Supply and install skids:

- Provide separate pricing for containers with and without skids, specifying the overall height (OAH) measurement with skids installed.
- Provide and install pocket-mounted skids for each of the 16 containers to ensure they are elevated off the ground.

Deliver containers to the specified Edmonton area location and unload:

- Transport the containers to the designated location in the Edmonton area.
- Ensure the containers are unloaded safely and placed in the specified positions, adhering to all legal and safety regulations and site-specific policies.

Milestones

The project is expected to be completed within the following timeline:

- Bid start: March 13, 2025
- Clarifications and questions due: March 19, 2025
- Bids close: March 26, 2025
- Bid awarded: April 2, 2025

Mandatory Submission Requirements

- Provide an itemized quote for each part of the scope of work.
- Specify the expected timeframe for completing the entire scope of work.
- Ensure secure transport within legal parameters.
- Adhere to site-specific personal protective equipment (PPE) requirements during loading and unloading.
- Provide references from previous clients.
- Submit proof of SFC/NSC satisfactory unaudited or higher rating and R-factor rating at or below intervention monitoring (if applicable).
- Submit proof of WSCC/WCB/WorkSafe account in good standing.
- Submit proof of commercial general liability (CGL), automobile, & liability insurance with a minimum coverage of \$2 million.
- Submit proof of cargo insurance with a minimum coverage of \$25,000.

Evaluation

Proposals will be evaluated based on the following criteria:

- Experience and qualifications of the contractor.
- Completeness and feasibility of the proposed project plan.
- Cost-effectiveness of the proposal.
- References and past performance.
- Compliance with safety and regulatory requirements.

Confidentiality

All information provided in this RFQ and any subsequent communications must be treated as confidential and proprietary to IRC. Proponents must not disclose any related information without prior written consent.
