

# Request for Quote: Removal of Northern Images Building and Related Earthworks

## Introduction

Inuvialuit Regional Corporation is inviting qualified contractors to submit quotations for the removal of the Northern Images building and related earthworks as described below.

# **Background**

Inuvialuit Regional Corporation (IRC) was established in 1984 to manage the settlement outlined in the Inuvialuit Final Agreement (IFA) and to represent the collective interests of the Inuvialuit. IRC's mandate is to continually improve the economic, social and cultural wellbeing of the Inuvialuit through the implementation of the IFA and by all other available means. Today, IRC is made up of 53 organizations with 375 employees.

# **Project Overview**

IRC is seeking qualified contractors to relocate the Northern Images building and perform associated earthworks at two key locations in the community. The building, located at 115 Mackenzie Road, Inuvik NT, will be moved to a designated IRC site on Navy Road (Block 51), Inuvik NT. The front section of the building must be preserved for future re-installation, while the rear section may be demolished. The Northern Images sign must also be removed and preserved.

In addition to the relocation, the contractor will be responsible for completing earthworks at both the current Northern Images site and the old Eskimo Inn lot at 133 Mackenzie Road, Inuvik NT. These sites are being prepared for use as parking areas, trailer space and generator installation. This includes grading, leveling, adding appropriate fill and ensuring proper drainage and access for vehicles.

The work will support IRC's infrastructure needs by repurposing assets and improving land use.



# **Scope of Work**

### 1. Move the Northern Images Building

- Move the building from 115 Mackenzie Road to the IRC site on Navy Road (Block 51), as shown on the map in Schedule A.
- Preserve the front section of the building for future reinstallation.
- Demolish the rear section of the building.
- Carefully remove and preserve the Northern Images sign.

## 2. Earthworks at the Northern Images site

- Grade the site to support vehicle and office trailer parking.
- Level the area near the utilidor to accommodate a skidded generator.
- Ensure the surface is compacted and stable for long-term use.

### Earthworks at the Old Eskimo Inn Lot

- Prepare the site for use as a parking lot:
  - Level the ground to ensure proper drainage.
  - Create a firm surface that won't become muddy in wet conditions
  - Add ¾ crushed fill as needed to stabilize the surface.
  - Grade the drive-in and drive-out access from Mackenzie Road.
  - Remove and dispose of any monuments (red pipes protruding from the ground) and subsurface materials.
  - o Finish the surface with aggregate to create a flat, usable space.

# **IRC** Responsibilities

IRC will handle the following before the relocation begins:

- · Disconnecting the power line
- Disconnecting and capping the gas line
- Disconnecting and removing the Utilidette



# **Project Milestones and Timeline**

The project is expected to be completed within the following timeline:

• **RFQ Issuance:** May 27, 2025

• Clarifying Questions: May 29, 2025

• Proposal Submission Deadline: June 9, 2025

• Contract Awarded: June 12, 2025

 Contract Completion Date: June 18 for building removal, June 22 for earthwork.

### **Submission Requirements**

Safety documentation in line with the Northwest Territories Safety Act and OHS Regulations, including:

- Proof of registration and good standing with the Workers' Safety and Compensation Commission or ability to register with the Commission.
- If any major components are manufactured elsewhere, proof of registration and compliance with local health and safety regulations must be included.
- Proof of valid commercial liability insurance, including coverage limits and policy dates, is required to cover potential damage or injury during contract performance.
- A detailed cost breakdown for the entire scope of work, including individual costs for each deliverable.
- References from previous clients.

IRC may request additional safety documentation at any time.

# **Evaluation Criteria**

Proposals will be evaluated based on:

- Inuvialuit Business List (IBL) Member: Preference given to active members of the IBL.
- Experience and Qualifications: Relevant past work and team credentials.
- **Sustainability:** Commitment to sustainable building practices and materials.



Cost: Fairness and transparency of the proposed budget.

All information provided in this RFQ, and any subsequent communications must be treated as confidential and proprietary to IRC. Proponents must not disclose any information related to this RFQ without prior written consent.


