Background

Inuvialuit Petroleum Corporation (IPC), through its wholly owned subsidiary Inuvialuit Energy Security Project Ltd. (IESPL), is moving forward with the development of the M-18 well and associated infrastructure as part of the Inuvialuit Energy Security Project (IESP).

As part of the construction phase, IESPL is seeking qualified suppliers to provide hoarding materials required for site preparation and protection.

Scope of Supply

IESPL is inviting expressions of interest (EOIs) from suppliers who can provide the following hoarding materials. The most critical items are timbers. Split or partial orders from multiple vendors are acceptable to meet the total quantity.

Timbers must:

- Be at least 4 feet long (8 feet or longer preferred for easier trailer loading)
- Be rough sawn (S4S specification not required)
- Be stacked and securely strapped for truck transport

Critical Items:

- 12"x12" timbers – approx. 500 lineal feet
- 8"x8" timbers – approx. 1500 lineal feet
- 4"x4" timbers – approx. 1500 lineal feet

Optional Items (if available):

- 2 lifts of ½-inch exterior-grade plywood
- 1 lift of ¾-inch D-grade plywood
- 1 lift of 2x4x12-foot lumber
- 1 lift of 1x4x12-foot lumber
- 8 rolls of 7'4"x136' 10-mil reinforced PE or fibreglass-reinforced plastic
- 2 boxes of 2-inch deck screws

- 2 boxes of 2³/₄-inch deck screws
- 8 rolls of 6-inch wide marine shrink tape (Uline S-16158W)

EOI Submission Requirements

Interested proponents should submit an EOI that includes:

- A brief profile of the proponent, including relevant experience and capacity.
- Confirmation of ability to supply the listed materials, including availability and delivery timeline.
- High-level commercial terms, including pricing, payment terms and any special conditions.
- Any additional value-added services, such as delivery to site, packaging, etc.

Note: Priority will be given to active members of the Inuvialuit Business List (IBL).

Delivery Terms

Delivery terms: FCA – supplier location (materials must be loaded onto IESPL's trailer)

Pickup deadline: on or before September 5, 2025

Confidentiality

All information provided in the EOI, and any subsequent communications, must be treated as confidential and proprietary to the IESPL. Proponents must not disclose any related information without prior consent.
